Also, our directors and registered members have been busy with community-volunteer fund raising, inter-departmental strategic task force meetings, providing governance direction at Board meetings, letter/email writing campaigns and individual advocacy of our dream **...**"to create a culturally inclusive Designated Supportive Living Facility in Fort Vermilion by 2020."

## Accomplishments/Progress Since 2017 AGM:

- 9 Regular Board meetings held
  - o 41 Motions Made
  - ~15 hrs of Actual Meeting Time
  - 100's of coordination emails/ phone calls and several blocks of paper, printer ink and pencils....
- 1 Special AGM meeting held
  - o Bylaws Amendment for Service Alberta Annual Society Return
- Invited to Give Presentation on Our Story in Ottawa to the Federal Standing Committee on Indigenous and Northern Affairs (INAN)
- (iii) 14 Letters Written to Elected Officials & 3 Letters of Response
  - Including: Alberta's: Minister of Heath, Minister of Seniors and Housing, Minister of Indigenous Relations. Canada's: Minister of Crown-Indigenous Relations, and Minister of Employment, Workforce Development & Labour, Minister of Health, Minister of Indigenous Services, and Minister of Seniors.
  - Additionally, each letter was appropriately cc'd to MLA Debbie Jabbour and MP Arnold Viersen.

## • 5 Multi-Departmental Task Force Meetings Held (& 2 Sub-Committee Meetings)

**Key Message:** The seniors and elders of Northern Alberta's Mackenzie region are in desperate need of a 'Culturally Inclusive' designated supportive living (DSL) or advanced care facility. Our existing facilities currently have a two year wait list, and for over ten years we have been calling on municipal, provincial and federal government to help us provide better care in a more compassionate timeframe. Healthcare is a multi-jurisdictional issue; therefore, we are asking Ministers and Senior Staff to formally provide support and direction on a multi-jurisdictional task force. A task force with a budget and political direction can implement change in the provincial and federal partnerships devoted to seniors and elders care, which will ultimately provide the Mackenzie region with the right facility to meet present and future need.
